To Our OC Raw Distribution and Retail Partners:

We are voluntarily recalling one lot of Chicken, Fish & Produce with lot #3652 with the use by date of 101118. This Lot was approximately 1560 lbs. and was manufactured on October 11, 2017. **We will be issuing a press release in the next few days.**

We were notified by the FDA on 3/28/2018 that this lot tested positive for Listeria Monocytogenes. We were also notified that the same lot tested negative for salmonella. In addition to the Chicken, Fish & Produce, our Pumpkin Rox with lot number 3597 was also tested for Listeria Monocytogenes and Salmonella and the results were both negative. The New Jersey Department of Food and Agriculture pulled and tested the product and notified the FDA.

We are conducting a full investigation to the source of the contamination. We have requested additional documentation, split sample and strain analysis for the sample of lot #3652. We hired an independent lab to test samples of ingredients, equipment, freezers, kitchen utensils like trays and buckets to insure our facility is pathogen free. All tests resulted in a negative presence of Listeria.

**Our records indicate this food was sent to California, Colorado, Florida, Vermont, Maryland, Minnesota, and Pennsylvania.**

Distributors:

An email was sent to all distributors who received lot 3652. Most distributors did not have any product in inventory. If you have any product please pull from inventory and destroy. Please take a picture of the lot sticker and send to olivia@ocrawdog. Please include the quantity and product type i.e. patty, slider, 3 lb. and or 7 lb. meaty rox and we will issue a credit for the recalled product.

Please notify all Retailers or Consumers who may have received lot 3652 of from 10/18/17 to 12/31/17 or to date if you had product in inventory. Please send Olivia a list of Retailers or Consumers who may have purchased lot 3652.

Retailers:

Please notify your customers who may have purchased lot #3652 of our voluntary recall. Your customers should be returning product to the retailer where they purchased. If / when you have lot #3652 returned please take a picture of the lot sticker and the product type i.e. patty, slider, 3 lb. and or 7 lb. meaty rox and send to your Distributor for a credit. Be sure to include quantity of bags returned. You may destroy the product. You do not need to return to Distributor for destruction.
